Services

Opening Services - All prices include the removal, cleaning, and storing of pool cover on owners property. Installation of ladder and handrails, reassemble 1 filter system and 1 cleaner pump for summer operation.

- Pool and Spa \$450
- Pool Only \$400
- Weekly Maintenance (up to 50 Minutes) \$100
- Waste-Vac Service \$120/hr
- Service Calls \$135/hr
- Feature / Booster Pump \$50
- Additional Filtration System \$100

Maintenance Visits

Typically done on a weekly basis includes the following services per visit:

- Vacuum pool and spa
- Skim the surface for any floating debris
- Test pool water chemistry for proper chlorine, bromine, pH, alkalinity, calcium hardness phosphate level, CYA, Salt and treat as necessary.
- Backwash filtration system as necessary
- Brush down tile line and walls as necessary (Monthly)
- Empty pump and skimmer baskets
- Furnish service report at the conclusion of each visit.

Note: All chemicals upon opening and per maintenance visit will be an additional charge.

Note: Any excessive water or debris removal from cover at pool opening will be an additional charge of \$60 or more.



Note: Please raise water level of pool to mid tile prior to opening to ensure proper system operation during that visit. If additional visit is required there will be an additional charge.

Terms:

1. Annually have a licensed electrician, experienced in swimming pools, inspect and certify that your equipment is properly grounded, protected by GFCI circuits and in safe operating condition.
2. Easy Swimming Pool Service, LLC ("ESPS") shall not be held responsible for any damage to the pool, it's decks, or other related parts due to hydrostatic pressure should it occur at any point during the emptying, cleaning, painting or time of filling. ESPS shall not be held responsible for any damage to lawns, shrubbery, or landscaping due to discharging of water and its contents when emptying the pool for cleaning or back washing or from any chemical applications. ESPS shall not be responsible for any damages existing prior to or following services performed by ESPS unless specifically due to the negligence of ESPS.
3. By signing this Agreement and engaging the services of ESPS: (1) you are assuming the risk that damage to your property may occur through no fault of ESPS at your own cost(s); and (2) representing that your property, pool, and pool equipment is in safe and operable condition.
4. This Agreement becomes a valid contract upon our receipt of the attached card properly signed by home owner (or lessee), accompanied with the required remittance and accepted by ESPS. No alterations to these terms will be applicable unless signed and dated by both parties.
5. Should payment on this account be in default and should it be necessary for ESPS to obtain legal representation and/or institute suit for collection then the owner or lessees agree to pay in addition the amount due and owing, interest thereon: and, any and all reasonable attorneys fees and costs of collection efforts or a lawsuit.
6. It is expressly understood that ESPS operates from Bucks County and that you are engaging a Bucks County based company. Should any disputes arise from services provided by ESPS, you expressly agree to bring any legal claims against ESPS in Bucks County and agree to have any claims brought against you in Bucks County. Should any claim be brought involving ESPS in a county other than Bucks County, you consent to the dismissal or transfer of such claim(s) to a court within Bucks County.

Your acceptance of this proposal will be assumed by returning the signed portion below to our office.
